From the Chair Dear Colleagues, October, 2009 is Archives Month in Kentucky!

Kentucky Archives Month is a yearly celebration of the importance of archives and historical records and of the work of institutions which preserve valuable these resources. Everyone (including archives, archivists, records managers and others who work with and care for these historic items) is encouraged to participate in the event/s.

We have planned the KCA fall meeting to coincide with Kentucky Archives Month, so, mark you calendars, now, and plan to attend our KCA fall meeting on October 9 at the Kentucky Historical Society (KHS) in Frankfort, KY!

Our meeting will focus on Kentucky's military history as well as military records and archival material from local battles and battlefields. Our speakers will share their knowledge of these topics; from the War of 1812 to World War II. In addition, attendees will have the opportunity to take an optional tour of the Kentucky Military History Museum (Arsenal) at the conclusion of the meeting.

Barbara Teaque, State Archivist and Records Administrator / Director of Public Records Division will open the meeting with some information about the State Historical Records Advisory Board (SHRAB). One of SHRAB's strategic goals is to work more closely with the KCA and they will now be featured at each of our upcoming Barbara will discuss meetinas. historical records, in general, at this meeting.

Mr. Brandon Slone, current Military Historian for the Kentucky Department of Military Affairs, will speak about the War of 1812 in our state. Mr. Stuart Sanders (KHS) is former executive director of the Perryville Civil War Battle site. He will speak to our group about the aftermath of the Perryville battle, archival materials at the battlefield and where other Kentucky Civil War archival materials can be located. From the Kentucky Department of Libraries and Archives (KDLA), we will welcome Mr. Walter Bowman who will speak to our group about World War I records stored at the KDLA in Frankfort.

#### DIRECTIONS TO THE KENTUCKY HISTORICAL SOCIETY

**From the west** on I-64, take Frankfort exit #53B onto U.S. Hwy. 127 (north from Lawrenceburg). Stay on U.S. 127, crossing U.S. Hwy. 60, and descending to the Kentucky River. After crossing the bridge, U.S. 127 becomes Clinton St. Follow Clinton St. (one way) through the traffic light at the bridge, under the Capital Plaza, to the next light at Ann St. Turn right onto Ann St. (one way). Drive one block, just past the Kentucky History Center, to Broadway. Immediately after crossing Broadway and the railroad tracks, turn left into the parking lot.

**From the east** (Lexington) on I-64, take Frankfort exit #58 at U.S. Hwy. 60. Turn right onto U.S. 60 (east from Versailles). At the junction of U.S. 60 and U.S. 421, turn left onto state route 676 (East-West Connector). Follow this curving road to the second traffic light. Turn right onto state route 1659 (Martin Luther King Jr. Blvd.). Turn left onto E. Main St. at the first traffic light. Descend the hill, through two traffic lights, passing the Frankfort Cemetery on your left. Before reaching the bottom of the hill, the rear of the Old State Arsenal, home of the Kentucky Historical Society's Military History Museum will be visible on your left. Parking is in the rear. Proceed just past the Military History Museum to the traffic light (use right-most lane) opposite the Capitol Ave. Bridge. Drive through the light, and then turn right onto High St. (one way). Move to the left lane as soon as possible. Turn left at the railroad tracks onto Broadway (there is no traffic light here). Drive past the Kentucky History Center and turn left at the traffic light at Ann Street. Immediately after crossing Broadway and the railroad tracks, turn left into the parking lot.

#### Kentucky State Archivist elected Vice President of Council of State Archivists

The Council of State Archivists (CoSA) elected Barbara Teague, Kentucky State Archivist and Records Administrator and Public Records Division Director at the Kentucky Department for Libraries and Archives (KDLA), as Vice-President/President-elect at the recent CoSA annual meeting in Austin, Texas. CoSA is the national organization of state archivists in each state and territorial government.

The Council of State Archivists works to ensure that our nation's historical records are valued, preserved, and widely used. CoSA works collectively to encourage cooperation among the states and State Historical Records Advisory Boards, to define and communicate archival recordkeeping and issues and concerns, and to work with the National Archives and Records Administration, the National Historical Publications and Records Commission, and other organizations to ensure that the nation's documentary heritage is Some of CoSA's preserved and accessible. current projects include managing a Federal Management Emergency Administration (FEMA) grant, Intergovernmental Preparedness for Essential Records, to develop recordsrelated emergency preparedness training for state and local government officials, and on passage of the Preserving the American Historical Record bill, H.R. 2256, to support the preservation and use of historical records.

Teague is a graduate of Harlan High School in Harlan, Kentucky, the University of Kentucky, and the University of Virginia. She has worked as an archivist at KDLA since 1983, and was appointed Kentucky State Archivist and Records Administrator in February, 2008. She served CoSA on several committees and project teams, before her election to the CoSA Board of Directors in 2008. The database currently contains images of thousands of items in the collection and the staff adds more daily. Users can request more information or even order images online.

#### U of L Wants Flood Photos

The University of Louisville Libraries are asking both the U of L community and Louisville residents to submit digital photos and videos of the recent flood for use in an archived community collection. The collection will document the flood, one of the worst in the city's history, through those who lived it.

In addition to creating the collection, some of the images will be shared on an August 2009 Flood website hosted by the Libraries Digital Collection.

Contributors can e-mail digital files to digital@louisville.edu, or send them to University Archives and Records Center, University of Louisville, Louisville, Ky 40292, Attention: Rachel Howard. Contributors are required to sign forms giving the libraries permission to preserve and post their images. The form available is at http://louisville.edu/library/giving/DeedOfGift.p df. They also should complete a second form, located

<u>http://louisville.edu/library/giving/PhotoInfo.do</u> <u>c</u>, which provides information about where and when the images were taken.

As a member of the MetaArchive Cooperative, the libraries will have the digital files replicated and stored at six different geographic locations so they are not lost due to natural disasters or other problems. The MetaArchive Cooperative has previously preserved documentation of disasters in New Orleans and at Virginia Tech.

The University Libraries' Digital Collections, launched in 2007, now offers over 17,000 items in seventeen digital collections. The August 2009 Flood collection will be Digital Collections' first community collaboration.

- 3. Anticipating a career change or simply want to know more about the professions of archives management, museum management, or records management...
