Letter from the Chair:

It's hard to believe the autumn equinox is on the horizon, when it seems the summer has just begun. The turning leaves and cooling temperatures of autumn mean that the KCA Fall meeting is right around the corner. Thanks to the membership's participation in last year's member survey, we have been able to use the feedback to structure our meeting to address the needs expressed in the survey results. A resounding request for more networking opportunities surfaced, as well as the desire for further instruction on outreach and access strategies. You've got it!

On behalf of the KCA board of directors, I welcome you to join us this October 5th for an exciting and engaging meeting. We will begin with a "lightening round" meet-and-greet during which attendees will be invited to introduce themselves, share a bit about their institutions and their current projects. This exercise will facilitate getting to know your fellow KCA members and further networking. The remainder of the fall meeting has a dual focus of "inreach" – an examination via a panel of representative archive user groups regarding how we are supporting and meeting their needs, and "outreach" – featuring a selection of projects by Kentucky colleagues working to bring archives to others.

In other KCA news, during the Spring meeting this past May members voted into action two new constitutional changes which will become effective in January 2013. First, the membership dues for the Kentucky Council on Archives increased from \$10 to \$20 per calendar year. This increase to dues is the first in over twenty years and will help to keep KCA financially solvent and in a better position to serve our mission. Second, members voted to change the constitution to require only one mandatory meeting per calendar year. This constitutional adjustment preserves the option to hold a second meeting if deemed necessary by one-third of the dues-paying membership and/or the administrative board. Should the KCA board not hold a second meeting per calendar year, we hope to fill that opening with a networking and/or professional development event.

Finally, as Chair of the Kentucky Council of Archives, it is an honor to be a part of and to serve the Kentucky archival community. I am continually inspired and engaged by my Kentucky colleagues and hope that our equivalents in other states are as fortunate to enjoy similar community and engagement. Thank you for your continued support and participation in this professional community and the Kentucky Council on Archives.

Regional News

Worker Sentenced for Tampering with Public Records

A former state social worker with the Cabinet for Health and Family Services was sentenced on July 24, 2012 to five years in prison for falsifying child-abuse and neglect reports. Margaret "Geri" Murphy, pleaded guilty in May to nine felony counts of tampering with public records, a Class D Felony. The charges, according to Attorney General Jack Conway's office, relate to Murphy's role as a front-line worker who falsified her reports while investigating allegations of child abuse and neglect in Anderson County.

Murphy was investigated by the Attorney General's office, and prosecuted under KRS 519.060, Tampering with Public Records. This statute was passed in 1992, and made falsification, theft, mutilation, or destruction of government records without authority a criminal offense. In this instance, this worker was convicted for making false entries in the case files of children she was assigned to protect.

Northern Kentucky University (NKU) News

The University Archives opened a major exhibit *Celebrating Dreams: the Presidency of James C. Votruba* in April to honor and reflect on the tenure of its longest-serving president. President Votruba retired from the university in July after serving as its leader for fifteen years. Through photographs and objects, this exhibit illustrates President Votruba's deep commitment to student success and the university's public engagement.

Steely Library's Special Collections and Archives will host the exhibit *Kentucky Impressions: Paul Sawyier Original Work* from September 22 - December, 9, 2012. The exhibit features 65 oil and watercolor paintings by Kentucky impressionist Paul Sawyier (1865-1917) who is well loved for his landscapes. This exhibit is sponsored by the Cincinnati/Northern Kentucky International Airport, Rosemary and Mark Schlachter, the Northern Kentucky University Foundation, Paul Sawyier Galleries, and Mary Ran Gallery.

Since July 2011, SC&A NKU has been contributing to Historypin, an interactive site designed by the organization We Are What We Do for individuals and institutions to share historic material using Google maps. NKU recently added over 225 digital images of Kentucky postcards from the Gilliam Postcard Collection onto Historypin in an effort to engage new audiences and to promote diverse ways of viewing the Gilliam Postcard Collection. Kentucky Historical Society (KHS) Acquires New Collection

The Kentucky Historical Society (KHS) recently acquired a collection of 19th century letters that depict the lives of both free and enslaved Kentucky families, in Lexington and Hopkinsville. Referred to as the Watson and Robinson letters, these handwritten documents contain detailed family history information and offer a glimpse into the African-American communities in those two Kentucky cities.

The collection contains a total of 27 letters, with the earliest dated 1841. Locations mentioned in the letters include Hopkinsville; Lexington; Paducah; Mississippi City, Miss.; Brandon, Miss.; and Williamson County, Ill.

“These letters are really a treasure trove of family history information,” said Louise Jones, director of KHS Library and Special Collections. “They offer a rare glimpse into the lives of both free and enslaved African-American in Kentucky.”

The Watson family letters – penned mostly by Isabel Watson – originated in Mississippi and include news of a family’s health, activities, church and religion, births and deaths; and describes slavery in Hopkinsville. The Robinson letters originate in Lexington and describe important family matters such as a wife’s death, the children’s health, a remarriage, the farm and freedom.

The Watson and Robinson Families Letters collection was purchased by Kentucky Historical Society Foundation, a private nonprofit organization that exists to support the mission of KHS. The letters have been catalogued and digitized and are now available for researchers. The Filson Historical Society is pleased to welcome a new colleague to our staff: Ms. Heather Fox. As Associate Curator of Special Collections, Fox will oversee the Filson’s photographic and print collections. Fox holds an MSLS from the University of Kentucky, serves on the State Historical Records Advisory Board and is Kentucky’s membership representative for MAC.

In other Filson news, the D. X. Murphy & Bro., Architects Records are now processed and accessible for researchers. The collection is comprised of historic architectural drawings and business records generated by two renowned architects: Henry Whitestone (1819–1893) and D. X. Murphy (1853–1933). With materials dating between 1854-1949, this collection documents Louisville’s rich architectural history and provides invaluable information about regional industry, contractors, business, and culture as it relates to the architectural landscape.

Kentucky State Archives Staff Offers Records Management Training

This summer, staff members at KDLA's Public Records Division (PRD) have undertaken a training initiative for State Agency Records Officers and other employees involved in records management. PRD staff offered a bimonthly workshop called "Records Management Policies and Procedures: A Review (or: What Do I Do with All this Stuff?)" that addressed various areas in management of Kentucky's government records. These included direct services provided by PRD, records retention scheduling, electronic records management and preservation, records transfer and storage, records destruction, and the documentation involved in all of these. By the end of August, PRD staff will have trained over seventy staff from a variety of state-government agencies. The workshops will continue to be offered monthly.

Kentucky State Archives holds Annual Archives Institute

The Kentucky Department for Libraries and Archives (KDLA) held its 28th annual Kentucky Archives Institute on June 22, 2012. The Institute, co-sponsored by the Friends of Kentucky Public Archives, Inc., provides information for scholars, general researchers, and genealogists interested in archival research.

J. Mark Lowe, CG, FUGA, was the featured speaker at this year's event. His talk, "*The Commonwealth vs. James Jones: Following a Case through Court*" provided attendees with an opportunity to trace the documents in a court case. Speakers from KDLA included Walter Bowman, who talked on Kentucky's Confederate Pension Applications; David Kirkpatrick, who addressed the 1940 United States Census; and Mark Myers, who gave tips on digitizing and organizing family records. Participants also had the opportunity to tour the Kentucky State Archives.

Fifty-five attendees participated in this year's Institute, the largest audience in several years.

Becky Ryder retires from University of Kentucky; Accepts Position at Keeneland

Since 1962 the University of Louisville Photographic Archives has grown to over two million images by hundreds of internationally known and emerging photographers, along with major collections such as the Roy Stryker Papers, Standard Oil (New Jersey) Photo Documentary Project, Caufield and Shook, and Fine Print collections. For the 50th anniversary we have organized an exhibition featuring the work of contemporary photographers alongside photographs that they have chosen from the archives. We have invited esteemed local photographers and friends of the Photographic Archives to submit work that reflects or is inspired by works in our collections. This pairing of contemporary and archival photography is meant to illustrate the significance of the Photographic Archives as a consummate resource that remains open to all artists, students, researchers and casual browsers alike.

The Photographic Archives houses almost 2 million photographs and associated records and manuscripts. Its mission is to collect significant documentary, local, and art photograph collections, to organize the collections and to make them available to the public. This is accomplished through our reference service, subject files, exhibitions, publications, digital collections, and other programs. Hundreds of discrete collections include national documentary projects, local history photographs and an excellent museum collection of fine prints. Collections include works by photographers like Dorothea Lange, Russell Lee, Paul Strand, Esther Bubley, Ralph Eugene Meatyard, Aaron Siskind, Alfred Stieglitz, Gary Winogrand, and Edward Weston among many others.

News from Special Collections & Archives, Hutchins Library, Berea College

Southeastern Kentucky Vietnam Combat Veterans Oral History Collection added to the Southern Appalachian Archives: This collection consists of audio recorded interviews with 22 southeastern Kentucky military veterans who served in combat during the Vietnam War. Generally the interviews focus on the personal, social, and emotional aspects of wartime military service instead of technical accounts of battles, logistics, and military operations. Subjects include personal military experience (being drafted or enlisting), education (military training, life lessons), food, communication, humor, friendships, travel, relationships, medical treatment, veterans' activities, and effects of military service on later life. The interviews were recorded between May and September 2011 by Jerry L. Clark, a Vietnam combat veteran who grew up in Whitley County, Kentucky. After military service he completed bachelors, masters, and doctoral degrees and worked as a clinical social worker for the United States Department of Veterans Affairs.

Audio / Video Digitization Project: Hutchins Library's Special Collections & Archives is in the midst of a multi-year effort to digitally preserve many hours of traditional music, college events and oral history. Dating as early as the 1970s, these recordings were made on now obsolete audio and video tape for which play back equipment is no longer available. The various formats are being digitized and stored first on external hard drives and eventually on servers in the College's Computer Center. DVD / CD user copies are available in Special Collections and many of the recordings will soon be available online through Hutchins Library's **Sound Archives Search Page** (<http://www.berea.edu/hutchinslibrary/specialcollections/specialsound.aspx>) and a comprehensive Library Guide for Archival Sound and Video Collections (<http://libraryguides.berea.edu/content.php?pid=339743>).

Urban Appalachian Council Papers Part I, to Open in September: Berea College's Special Collections & Archives is excited to announce the opening of Part I of the Urban Appalachian Council (UAC) Papers, 1930 - 1994. Just one segment of this large collection, Part I's 100 manuscript boxes include early history and organizational files, board minutes, committees, and programming. Organized in Cincinnati, Ohio, the UAC has acted as a regional resource and educational center for Appalachian affairs promoting cultural heritage among urban Appalachians. Working with and for Appalachian migrants, the UAC functions under a commitment to cultural pluralism which guides the UAC's work in research, advocacy, community organization, cultural affirmation and program development. Under the direction of Jaime M. Bradley, College Archivist, the papers were processed by Lori Myers-Steele as part of a summer 2012 graduate internship in archival studies at East Tennessee State University.

Shannon H. Wilson Leaves Berea: Shannon H. Wilson, long time Berea College Archivist and most recently Head of the Department of Special Collections & Archives will leave Berea in August 2012 to follow his clergy person wife who has accepted a call to Calvary Episcopal Church in Tarboro, North Carolina. Shannon began working in the Kentucky archives community in 1984 at the KDLA, before coming to Berea in 1985 as Project Archivist on the Settlement Institutions of Appalachia Project, funded by the National Endowment for the Humanities. In 1986, Shannon became College Archivist at Berea, a position he held until 2006 when he became Head of the Department. Shannon has served on the KCA Board (1988-1992), the Lincoln Bicentennial Commission College and University Subcommittee, the Kentucky Craft Education and History Association, and as Archivist for the Appalachian Studies Association. He has been a faithful servant within the KY Episcopal community, including work as archivist and consultant with the Episcopal Dioceses of Lexington and Christ Church Cathedral, also leading the Episcopal student group on Berea's campus. As colleagues and friends we hope you will join us in thanking Shannon for all his contributions and in wishing him much joy and success in his new adventures!

University of Louisville Upcoming Exhibit on Harry Potter's World

Harry Potter's World: Renaissance, Science, Magic, and Medicine explores the world of Harry Potter and its roots in Renaissance magic, science, and medicine. Catch the magic Oct. 20 through December 1, 2012 at the University of Louisville's Kornhauser Health Sciences Library

In 1997, British author J. K. Rowling introduced the world to Harry Potter and a literary phenomenon was born. Although a fantasy story, the magic in the *Harry Potter* books is partially based on Renaissance traditions that played an important role in the development of Western science, including alchemy, astrology, and natural philosophy.

Incorporating the work of several 15th- and 16th-century thinkers, the seven-part Harry Potter series examines important ethical topics such as the desire for knowledge, the effects of prejudice, and the responsibility that comes with power. This exhibition, using materials from the National Library of Medicine, explores Harry Potter's world and its roots in Renaissance magic, science, and medicine.

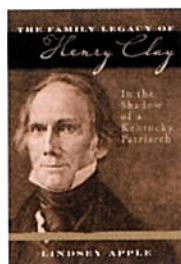

Kentucky State Archives Employees Attend Workshops Related to Digital Curation and Preservation

Jim Cundy, KDLA's State Records Branch Manager, attended the DigCCurr institute on May 20-26 at the University of North Carolina, Chapel Hill. DigCCurr seeks to develop an international, doctoral-level curriculum and network in the management and preservation of digital materials throughout their entire life cycle. The institute included participants from academic, governmental, and cultural heritage institutions. The institute's members are learning to facilitate and support long-term access and re-use of meaningful and authentic digital resources. Participants produced six-month plans based on their experience and knowledge gained at the institute and will reconvene in January to report on their progress. Beth Shields, KDLA's Electronic Records Analyst, and Mark Myers, KDLA's Electronic Records Archivist, attended last year's session of DigCCurr.

Beth Shields has been selected to take part in the Library of Congress Digital Preservation Outreach and Education (DPOE) Train-the-Trainer Workshop. The DPOE is building a network of instructors to assist staff at repositories in preserving digital content with permanent value. Attendees of the workshop receive the DPOE Baseline Digital Preservation Curriculum, and Library of Congress certification as DPOE Trainers who are able to teach the baseline curriculum to others. The workshop will be held August 21-24, 2012 at the Indiana State Library in Indianapolis.

Keeneland Library is now online!

The Keeneland Library has converted its manual card catalog into an online catalog supported and served by the cloud-based integrated library management system, Library World. You can access the Keeneland Library catalog via the Library's website <http://www.keeneland.com/discover/online-catalog>. This is the Library's first 24/7 access portal to its collections other than the *Daily Racing Form* online archive. <http://kdl.kyvl.org/drf> While the online catalog is mostly an index of collection titles and holdings, it also links to online, full-text sources at such sites as Google Books, Kentucky Digital Library and the Hathi Trust Digital Library when available.

Approximately 80% of the Keeneland Library's monograph and journal titles are included in the catalog. Work has begun to catalog special, unique collections and to represent them at the collection level in the catalog. Included in this category are the annual farm registries, the papers of noted turf writers such as Joe Hirsch, Oscar Otis and Maryjean Wall, and numerous collections of winner's circles photographs donated by Kentucky owners and breeders.

KCA attendees may park in the lots around building number 45 or find street parking.

Directions (available on Campbellsville University's website at: <http://www.campbellsville.edu/directions>)

From Louisville to Campbellsville University:

- * Take I 65 South to Elizabethtown
- * Take Exit # 91/Hwy. 61/Lincoln Parkway. Follow 15 miles, but do NOT turn right on Hwy. 61 in Hodgenville - continue on Hwy. 1618 to Hwy. 210
- * Turn right on 210 and follow 30 miles to Campbellsville
- * Turn left onto Broadway Hwy. 55/68, go to the stop light numbered 4 beside CVS Pharmacy, turn left onto N. Columbia Ave.
- * Go on North Columbia to first stop light - take a left onto University Drive (see C.U. sign)
- * Go one block to four-way stop. Go straight through four-way intersection and that brings you into a circular drive area in front of the Administration Building.

From Frankfort to Campbellsville University:

- * Take 127 south through Lawrenceburg to the Bluegrass Parkway
- * Go west on Bluegrass Parkway to the first Springfield exit (Highway 555 exit)
- * Go south on Highway 555 to Springfield and go straight on Highway 55 through stoplight and intersection and on to Lebanon
- * In Lebanon turn right at first stop light and follow signage for Highway 55 - at McDonald's in Lebanon go right, as Highway 55 continues. Stay on Highway 55 for nearly 20 miles
- * Enter Campbellsville on Highway 55
- * Go straight through five stop lights (through commercial areas and then by downtown area).
- * At the sixth stop light, go right onto North Columbia Avenue (CVS Pharmacy on right)
- * Go on North Columbia Avenue to first stop light - take a left onto University Drive (see C.U. sign)
- * Go one block to four-way stop. Go straight through four-way intersection and that brings you into a circular drive area in front of the Administration Building.

From Lexington to Campbellsville University:

- * Take the Bluegrass Parkway to Exit # 42/Hwy. 555, turning left at the end of the exit ramp
- * Hwy. 555 runs straight into Hwy. 55 South
- * Follow Hwy. 55 South through Lebanon and into Campbellsville
- * Go straight through five stop lights (through commercial areas and then by downtown area).
- * At the sixth stop light, go right onto North Columbia Avenue (CVS Pharmacy on right)
- * Go on North Columbia Avenue to first stop light - take a left onto University Drive (see C.U. sign)
- * Go one block to four-way stop. Go straight through four-way intersection and that brings you into a circular drive area in front of the Administration Building.

From Nashville/Bowling Green to Campbellsville University:

- * Take I-65 North to Exit #43/Cumberland Parkway
- * Take Exit #49/Hwy. 55 North through Columbia and into Campbellsville
- * Turn right at the intersection onto Broadway Hwy. 55/68 traveling east to the traffic light numbered 4 beside CVS Pharmacy
- * Turn left onto N. Columbia Ave.
- * Go on North Columbia to first stop light - take a left onto University Drive (see C.U. sign)
- * Go one block to four-way stop. Go straight through four-way intersection and that brings you into a circular drive area in front of the Administration Building.

Directions to Campbellsville University, continued

From Knoxville/Somerset to Campbellsville University:

- * Take Cumberland Parkway to Exit #49/Hwy. 55 North through Columbia and into Campbellsville
- * Turn right at the intersection onto Broadway Hwy. 55/68 traveling east to the traffic light numbered 4 beside CVS Pharmacy
- * Turn left onto N. Columbia Ave.
- * Go on North Columbia to first stop light - take a left onto University Drive (see C.U. sign)
- * Go one block to four-way stop. Go straight through four-way intersection and that brings you into a circular drive area in front of the Administration Building.

From Paducah/Owensboro to Campbellsville University:

- * From Paducah, take I-24 East to Western Kentucky Parkway
- * From Owensboro, take the Green River Parkway to the Western Kentucky Parkway
- * Take the Parkway to Elizabethtown
- * When entering Elizabethtown remain on the parkway. It will become Hwy.61 to Hodgenville
- * Turn right on 210 and follow 30 miles to Campbellsville
- * Turn left onto Broadway Hwy. 55/68, go to the stop light numbered 4 beside CVS Pharmacy, turn left onto N. Columbia Ave.
- * Go on North Columbia to first stop light - take a left onto University Drive (see C.U. sign)
- * Go one block to four-way stop. Go straight through four-way intersection and that brings you into a circular drive area in front of the Administration Building.
