News from Louisville is for Lovers

I am pleased to announce Louisville Is For Lovers has partnered with the Louisville Free Public Library in a new program entitled Louisville Mix. Louisville Mix is a free streaming service the Louisville Free Public Library will unveil on October 3rd (with a full comprehensive streaming service updated on January 20th) on their Website www.lfpl.org that will archive and stream music by Louisville bands. The entire Louisville Is For Lovers collection will be available to stream through Louisville Mix, as well as many other local bands. All of the Louisville Is For Lovers Valentine's releases will be available on October 3rd, and the entire 15 year catalogue will be available by January 20th.

The collection includes music from some of Louisville's best known artists, including Twin Limb, Andrew Rinehart, Cheyenne Mize, 23 String Band, Mudcat Blues Band, and others. Louisville Mix also features a number of albums from the popular "Louisville is for Lovers" collection—courtesy of founder and curator John King—which includes tracks by My Morning Jacket, Jim James, Wax Fang, and countless others.

The Louisville Free Public Library is also paired up with 37FLOOD (the first and oldest Louisville music blog) to help recruit local bands for the Louisville Mix Project.

October 3rd: Unveiling of Louisville Mix free streaming service on www.lfpl.org including the entire Louisville Is For Lovers Valentine's project as well as full albums by Louisville bands including Bodeco, Twin Limb, Cher Von, and others.

January 20th: Louisville Mix Showcase with Louisville bands at Louisville Free Public Library for an 'After Dark' event, in conjunction with 37FLOOD (in honor of 37FLOOD's 10th Anniversary).

February 10th: New Louisville Is For Lovers Valentine's release in partnership with Louisville Free Public Library's Louisville Mix streaming service.

Louisville Mix is a great way to introduce listeners to the wide variety of quality music coming from our city. To access this amazing free collection, visit LFPL.org/Music.
