Fall Meeting 2023

Hosted at the Filson Historical Society, the KCA Fall 2023 Meeting offered practical emergency response training as a follow up to the Spring 2023 Meeting, No Archives Unaware. Under the direction of Sara Holmes, a conservator at the National Archives and Records Administrator, attendees spent the morning getting their hands dirty and learning how to organize a response to an emergency, prioritize and handle materials, and observe the effects of water damage in particular.

In the afternoon, Leah Hamilton, Assistant Professor at the University of Kentucky

Department of Arts Administration, guided attendees through a variety of emergency scenarios. They were also challenged to create their own disaster scenarios and solutions, leading many to appreciate the need to audit risk for a safer and more resilient work environment.


