

KCA Continuing Education Scholarship Award

The KCA Board invites applications for the Continuing Education Scholarship Award. Awards are open to any person engaged in archival work in Kentucky; applicants are not required to be members of KCA.

TREASURY REPORT

Greetings!

20 members have renewed since May 1 (with 31 renewals over the entire previous year). 33 attended the Spring Meeting at the Sisters of Loretto. The organizational account received \$1,192.97 in dues and conference income since May 1, and earned \$32.04 in interest. Expenses in this period for the Spring meeting were \$799.99. There was a regular expense of \$43.34 for website domain renewal. There is a planned expense in December of \$648 to begin a pilot program for one

year of using the WildApricot system to process membership, dues, and deliver the website in the future. If successful, KCA would renew in December 2025 for two years at \$1,224 (\$51/month). This would potentially replace a Bluehost website hosting platform at \$21.99/month. Though the price is higher, WildApricot includes more features for KCA officers to manage memberships and conference registrations, and it allows members to manage their own directory and renewal information. KCA's ending total funds were \$12,008.72, up from beginning total funds of \$11,627.04 at the end of last April.

KCA Spring Meeting Re-cap

On May 31, 33 of the archival-inclined flocked together at <u>Loretto Heritage Center</u> for the KCA Spring 2024 Meeting. The meeting began with an opportunity for members to introduce and speak about their institutions in a Pass the Mic keynote. Afterward, attendees broke out into discussion groups, each focused on a different topic, such as digital archives, outreach and engagement, and processing and preservation.

Moderated by Ruth Bryan, the afternoon's "Archival Migrations" panel featured speakers Ginny Daley, who worked with the Presbyterian Historical Foundation in Montreat, NC; Kyna Herzinger, who routinely transfers records from the Presbyterian Church headquarters in Louisville to the denominational archives in Philadelphia, PA; Suellyn Lathrop, who worked on moving part of the Western Kentucky University Special Collections to the Cravens Library; and Reba Weatherford, who is preparing to move the Loretto Heritage Center collections to the Women's Religious Archives Collaborative in Cleveland, OH. The panelists discussed the planning, practical steps, relationships, outcomes, challenges, and opportunities involved in relocating collections.

The archival flock concluded the day with an outdoor tour of the facilities, showing the Center's rich history and demonstrating their commitment to caring for the environment.

Kentucky Department for Libraries & Archives Appoints Rusty Heckaman to State Archivist

Rusty Heckaman has been appointed State Archivist for the Kentucky Department for Libraries and Archives. The State Archivist is the Division Director for the Archives and Records Management Division. As the State Archivist, he will oversee the Archives and Records Management Division, which is comprised of the Archival Services Branch, Electronic Records Branch, Local Records Branch, and State Records Branch. The Kentucky Department for Libraries and Archives (KDLA) look forward to having him in this role.

Prior to coming to KDLA, Rusty was an instructor librarian at Austin Community College, and an Archivist at the Austin History Center, American Academy of Pediatrics, and Abbot Laboratories. He has been the Research Room Supervisor since 2021 where he has worked to make the resources more accessible to researchers, genealogists, and patrons. Rusty has also championed KDLA's collaboration with FamilySearch. Rusty has a bachelor's degree in history from Indiana University South Bend and a master's degree in library science from Indiana University Purdue University of Indianapolis. He is actively involved in the professional archival community including the Kentucky Council on Archives and the Society of American Archivists.

"To hold a position entrusted with the continued preservation of Kentucky's history is a privilege I will not take for granted. I am fortunate not only to play a role in this work but to be supported in these efforts by a passionate group of professionals dedicated to the continued collection and access of the documents recording these stories," said Rusty.

KDLA Partnering with FamilySearch

KDLA has partnered with FamilySearch to digitize and preserve tens of thousands of primary records, such as birth, death and marriage certificates that are currently on microfilm reels.

KDLA and volunteers from the Kentucky Genealogical Society (KYGS) are reaching out to the state's county clerks, the official custodians of these records, to notify them of the opportunity to have their records digitized free of charge by FamilySearch. They can take advantage of this opportunity simply by advising KDLA that their records may be digitized using a records release form. In return, the clerks and KDLA will receive copies of the digitized records, and FamilySearch will post a copy on their free online database.

"Local records are some of the most irreplaceable resources for the discovery of documentation of the commonwealth's populace. Records like those of marriage, probate and land ownership have been created from each county's origins, resulting in some of the most continuous sources of the state's history," said Rusty Heckaman, state archivist for KDLA. "Together they are invaluable to the genealogist and researcher alike for the picture they can help paint of our ancestors' lives. The participation of FamilySearch in the digitization of these records presents a huge opportunity to make these records more accessible to the public. Their increased use can only further promote the value these records hold and increase awareness of the wealth of resources in repositories like KDLA and in the courthouses throughout our state."

Washington County Clerk Records Treated

A collection of records was returned to the Washington County Clerk's Office vault in October Thanks to funding from the Local Records Emergency and Disaster Assistance Grant, Washington County Clerk Brett Barry has been able to have the records successfully treated for continued preservation concerns. The records consisted of four marriage bonds books and four deed books dating as far back as 1820.

Any Kentucky local government agency that has suffered damage which endangers public records or access to those records as a result of an emergency, disaster, or ongoing climate crisis is eligible to apply for KDLA's Local Records Emergency and Disaster Assistance Grant.
